

Dear Madam Speaker,

Please let this correspondence serve as a formal complaint against Representative Ron Weinberg filed on behalf of Representative Brandi Bradley for violating Amendment 41, campaign finance practices of the state of Colorado, along with what I believe to be harassment, theft and trespass. This complaint is being filed pursuant to House Rule 49, which requires the signed, written complaint be filed with the House Speaker.

Here is a list of what I believe to be several Amendment 41/campaign finance violations with data taken straight from Rep Weinberg's Tracer account (there are many, many more):

During the legislative session of 2023, Rep Weinberg, who smelled of alcohol was inches from my face screaming at me over a disagreement over a bill. I was completely shaken and ran to room 212 where I reported his behavior to my senior aide Jeff Patty who then confronted Rep Weinberg on the floor about his behavior. There were many mornings even before the roll call vote that I smelled alcohol on his breath and he always bragged about carrying a weapon in the Capitol to "keep us safe" which violates CRS 18-12-106. On multiple occasions, Rep Weinberg made inappropriate and sexual comments to me that were unwarranted and unprovoked, violating our workplace harassment guidelines. In Veteran and State Affairs this past session, he was so belligerent to Rep Luck that it made everyone on the committee feel uncomfortable, preempting me to text Assistant Minority Leader to come to the committee as soon as possible because I became fearful for her safety. On the last night of session this year, a group of about fifteen of us were sitting at a table at the Brown Palace. Rep Keltie was telling a story about how she almost lost her eye from a scuba diving accident and from across the table, Rep Weinberg yelled that she almost lost her eye from giving a hard blow job and then proceeded to talk about how she and Rep Johnson needed to dust off their vaginas and quit being celibate. I was completely caught off guard and asked the waitress for my check immediately. He also became more and more belligerent with my aid until we left.

The most egregious ethics violation that has taken me until now to come forward, is Rep Weinberg openly admitting to a group of us, on January 9, 2025, to making a copy of the master key to the Capitol. A key that had to be taken out of Kathy's desk, without her knowledge, and had someone make a copy of it. A key that opens every door to every office at the Capitol, every Democrat and every Republican legislator. Rep Weinberg then proceeded to use the copy of his key to let me into Rep Luck's locked office and turn on the light. At no time did Rep Weinberg tell me to wait and go down to the second floor and obtain the key from Kathy and come back up to open Rep Luck's office.

When Representative Luck came to work the next day she found out that this had happened and immediately went to Vanessa Reilly to report it. To my knowledge, no actual police report has been made and I would like to know the proceedings of doing that. I believe that this could violate trespassing and theft laws and it should not be swept under the rug. Both representative Luck and myself have had numerous conversations with Minority leader Pugliese and Assistant Minority leader, Ty Winter, and we were told that Weinberg's punishment was to be to be taken off of Legislative House Services committee and that the locks to the Minority and Majority leadership offices as well as Representative Luck's office would be changed.

We were also told that some of the cameras in the Capitol are just decoys. We were also told that there is a new system to obtain the key to borrow it as it is no longer being stored in Kathy's desk. Never once was it suggested that the locks to the entire staff's offices be changed. Colorado State Patrol replied to me and said the security risk had been alleviated, but how could that be alleviated if my lock has not been changed? How can the security be alleviated if he has a key to every single office in the Capitol? The answer is very simple, it does not change anything and the security of all of our offices is still at risk, not to mention that


* making a duplicate key (unless he was given permission to make the key) and going into another Representative's locked office seems to violate Joint Rule 36.


In addition, Several people have come forward to tell me that they spent New Year's Eve at the Capitol and watched Representative Weinberg pull out his personal key and open several locked offices. I am going to include the pictures that one of them took. I've also had several people come forward and say that he has taken them on private tours and unlocked doors with his personal key. This is a safety concern and it doesn't help that only eight door locks were changed.

This is of grave concern to me, and I have been wrestling with this for many months now, and it was brought even more to the forefront of my mind when he decided to run for leadership position. It is my belief that Representative Weinberg committed theft and he committed trespassing. I've been told by numerous Democrats that he has let them into their offices with his master key many times last session as well. The only decision that should be made is that he be brought in front of an ethics committee and his behavior be evaluated.
