Our Key Impacts and Successes

- Japanese Beetle infestation in Mesa County reduced by 85%
- Initiated R&D of biocontrol agents to combat corn earworm threatening Olathe sweet corn
- 116 small business reported \$10M in sales through 10 CDA trade missions (30:1 ROI)
- Implemented robust HPAI response measures that influenced national strategy for poultry and beef industries.
- Issued \$300K to mountain communities and embedded two range riders in first year of the Non-lethal Conflict Reduction Program.
- Issued \$5M in Community Food Access Grants across 42 counties
- State Fair recognized with 23 international and regional awards


- **Expanding Leadership Training:** Empowering 120+ current leaders with an additional 38 already committed for 2026, ensuring long-term culture stability.

Colorado For All

- **Economic Opportunity:** Participated in the Statewide Equity Office's Supplier Diversity initiative to broaden our economic impact and support a wider range of local businesses.
- **Modernizing Accessibility:** Strengthened our commitment to ADA by establishing Standard Operating Procedures (Title I) and refined policies (Title II) to ensure seamless access for all.
- **Systemizing Digital Access:** Became the 3rd state agency to complete our IT Checklist and increased our website scores. We're developing 5 online learning modules, embedding accessibility into the daily workflows for staff.



Federal Impacts

- USDA terminated \$18M in Climate Smart Commodities Grant Funding
 - Reapplied under the new Agricultural Markets Program
- Delayed grant and contract reimbursements at the beginning of the calendar year
- HR1(O BBB)
- USDA Workforce Reduction (20,000 staff, 18% of total workforce)
- Federal Shutdown
 - Access to Services
 - Delay in administration of programs and reimbursements













One Health recognizes that the health of people, animals, and ecosystems are all interconnected and interdependent.




CDA is striving to look at its work through this lens to ensure we aren't making decisions in silos and implementing solutions that serve all Coloradans by coming together as "one" community.

CDA FY 2026-27 Budget Requests

R-01: Budget Balancing Reductions:

\$356,556 on-going General Fund reduction. This proposal includes ongoing funding decreases at CDA of \$236,502 for the Commissioner's Office Personal Services and \$120,054 for the Plant, Health and Environmental Protection Fund.

R-02: Agrivoltaic Rollforward:

This budget-neutral request seeks an additional year of rollforward authority for Agrivoltaics Grants to ensure grantees have sufficient time to complete infrastructure-related work and fully expend awarded funds.

R-03: Long Bill Reorganization:

Colorado Department of Agriculture (CDA) requested R-03 in FY 25-26 to restructure its Long Bill lines in order to align certain funds & FTE in the Long Bill with their current division and promote transparency. This request was approved in concept during figure setting and CDA has been working with the Joint Budget Committee analyst to begin implementing these changes for the FY 2026-27 long bill.



Statewide Supplemental/Budget Amendment Request

S-02/BA-02 Mountain Pine Beetle:

- \$101,540 CF and .75 FTE in FY25-26 and annualizing to \$322,993 CF and 3.0 FTE in FY 2026-27.
- Request is part of a statewide coordinated response.
- Supplemental resources are requested to support innovative biocontrol research and deployment by the Department of Agriculture's (CDA) Palisade Insectary.



Continued Commitment to Budget Balancing

In addition to the **General Fund reduction of \$356,556** discussed previously, the Department has made the following additional reductions in collaboration with the JBC that were **approved by the General Assembly last session**.

General Fund Reductions

- One-time (FY 2024-25): \$1,290,569
- On-going (beginning FY 2025-26): \$1,776,444 (8.6% of GF budget)

Cash Fund Reductions

- One-time (FY 2024-25 and FY 2025-26) : \$1,222,895
- On-going (beginning FY 2025-26): \$340,730

Regulatory Agenda

In 2025, we conducted 10 rulemaking hearings, including:

- **9 rule revisions**
- **1 new rule**

In 2026, we have six rulemaking hearings planned, and 8 efficiency reviews including:

- **2 Division of Plant Industry rules**
- **4 Inspection and Consumer Services Division rules**
- **8 efficiency reviews will take place across the Animal Health, Conservation, Plants, and Markets divisions.**




Markets Update

2026 Outlook

- Farm profits forecast to drop to \$1.8B
- Beef industry will drive profits
- Grain & other commodity prices low in 2025, uncertainty for 2026
- Specialty crop producers struggling to find profitability

Cattle Prices

- Forecast to remain high in 2026
- Herd sizes still recovering, demand high/inventory low, consumers willing to pay

Tariffs

- Impacting profitability
- Higher input costs, unpredictable commodity prices
- Supply chain disturbances

- 2022 - current
- H5N1 continuing to circulate
- CO - ~10M domestic poultry, 75% of dairies
- Stage 4 status (dairy) - NMTS
- Looking ahead - vaccines

New World Screwworm

- Outbreak in Mexico
- US and CO preparedness and outreach
- CO December Workshop
- After Action Report - coming Q1 2025


