### **About This Report**

This report provides information on State Transfers and Diversions resulting from bills pending or enacted at the 2025 legislative session. Data is taken from the most recent published Legislative Council Staff Fiscal Note. The Summary Tab provides an overview of the net impact from all transfers/diversion by fiscal year. Data for individual bills is provided on the fiscal year tabs.

Transfers move money between funds. Diversions redirect where money is collected/deposited. In this report, negative numbers (in red/parenthesis) indicates that money is being transfer from a fund or diverted away from that fund. A positive number means that the fund is receiving money. Note that this report only shows bills that are still pending or have been enacted by the General Assembly AND that have a transfer/diversion in the three-year period covered by fiscal notes; other bills have been omitted.
